1. I HAVE PAID/JOINED THE LIFETIME RETIRED MEMBERSHIP --(\$125.00 Special Services dues). Applicable to retired school employees who were members of NSEA at the time of retirement. This membership category has already paid NSEA-Retired lifetime dues. Couples electing two single plans must both be Special Services members.
2. I WAS AN NSEA MEMBER THE YEAR I RETIRED --(\$185.00 Special Services dues). Applicable to retired school employees who were members of NSEA at the time of retirement. This category automatically includes an annual retired membership. Couples electing two single plans must both be Special Services members.
3. I AM A SPOUSE OF A RETIRED NSEA MEMBER --(\$125.00 Special Services dues). Applicable to spouses of retired school employees who were members of NSEA at the time of retirement.
4. I WAS NOT AN NSEA MEMBER THE YEAR I RETIRED --(\$250.00 Special Services dues). Applicable to retired school employees who were not members NSEA at their retirement. Couples electing two single plans must both be Special Services members.
5. I AM A SPOUSE OF A NON-NSEA MEMBER AT RETIREMENT --(\$250.00 Special Services dues). Applicable to spouses of school employees who were not members of NSEA at their retirement.

If you are an NSEA member and are not currently a lifetime member of NSEA-Retired, you can become a lifetime NSEA-Retired member and avoid paying annual NSEA-Retired dues.
