* The BCBSNE \$4,000 Deductible HSA-Eligible Retiree Health Coverage Plan prescription drug benefit is, on average for all plan participants, NOT expected to pay out as much as Standard Medicare prescription drug coverage pays. Therefore, this coverage is considered Non-Creditable Coverage. This is important because it may mean that individuals with the \$4,000 Deductible HSA-Eligible Retiree Health Coverage Plan may pay a higher premium (a penalty) if they do not join a Medicare drug plan when they first become eligible.
